RELEASE AND INDEMNITY

On behalf of myself, my parent, and subsidiary corporations, in consideration for the granting of permission to enter upon the property owned by Freeport-McMoRan, I release and agree to hold harmless and indemnify Freeport-McMoRan, its affiliates, officers, employees, and agents, from and against all claims and all injuries, losses, and damages to any person or property arising out of entry onto the company's operations from the date of this release.

FIREARMS

In accordance with A.R.S. 12-781, firearms are authorized to be transported onto and stored on company property only under the following criteria:

 The firearm must be in your locked privately owned motor vehicle or in a locked compartment on your privately owned motorcycle The firearm must not be visible from outside the motor vehicle or motorcycle

Transportation and storage of any firearm that does not meet the above criteria may result in disciplinary action consistent with company policy. This policy does not otherwise affect or limit the company's right to search any motor vehicle or motorcycle on company property.

PERSONAL PROTECTIVE EQUIPMENT – PPE

While in processing areas and work areas the minimum PPE must be worn

- Reflective Vest

SAFETY EYE WASH STATIONS

Eye wash stations are located throughout the Port of Tucson 6992 and XCE Facility. In the event you are exposed to a hazardous chemical proceed to the nearest station and flush with water for a minimum of 15 minutes, then seek medical care.

HAZARD RECOGNITION AND AVOIDANCE

- PPE is required in processing areas and work areas
- Everyone in a vehicle must always wear a ٠ seatbelt
- Stay clear of working mobile equipment and highway trucks as the operator may not see you
- No drugs or alcohol or explosives on premises including in personal vehicles
- Situational awareness must be maintained while outdoors for variable conditions etc. traffic, wildlife, lightning
- Be alert for slip, trip, and fall hazards
- Do not walk under suspended loads
- Use proper eye protection in areas where cutting and welding work is being done
- Visitors must have an escort when entering a location outside of their intended work area
- No smoking or vaping in buildings and ٠ observe all no smoking areas
- Emergency eye wash stations are located throughout site
- Xray is in use in several areas of the XCE Facility; keep out of areas when in use. Only properly trained personal shall operate this equipment.
- Microwaves are in use at our facility. If you have an implanted medical device (i.e., Pacemaker) ask about the specific location of microwave devices
