


# Technology Center Hazard Recognition

# **CONFIDENTIALITY AGREEMENT**

While on Technology Center property, use of photographic or video equipment or similar technology is prohibited without the express prior written consent if Freeport-McMoRan. In consideration for the granting of permission to enter the Technology Center property, I hereby agree all knowledge and information acquired or otherwise obtained by me relating to the site's operations may not be used by me for any purpose or divulged to any person other than authorized representatives of the Technology Center without the express prior written consent of Freeport-McMoRan.

# RELEASE AND INDEMNITY

On behalf of myself, my parent and subsidiary corporations, in consideration for the granting of permission to enter upon the property owned by Freeport-McMoRan Technology Center, I release and agree to hold harmless and indemnify Freeport-McMoRan, its affiliates, officers, employees, and agents, from and against all claims and all injuries, losses, and damages to any person or property arising out of entry onto the company's operations from the date of this release.

# **FIREARMS**

In accordance with A.R.S. 12-781, firearms are authorized to be transported onto and stored on company property only under the following criteria:

 The firearm must be located in your locked privately owned motor vehicle or in a locked compartment on your privately owned motorcycle  The firearm must not be visible from outside the motor vehicle or motorcycle

Transportation and storage of any firearm that does not meet the above criteria may result in disciplinary action consistent with company policy. This policy does not otherwise affect or limit the company's right to search any motor vehicle or motorcycle on company property.

# PERSONAL PROTECTIVE EQUIPMENT - PPE

When in lab and work areas the minimum PPE must be worn

- Safety toe shoes
- Safety glasses
- Long pants

Watch for signs in work areas listing PPE requirements. Certain work areas require additional PPE, see your area representative. Additional PPE requirements may include:

- Lab coats
- Approved chemical resistant suits/aprons
- Gloves
- Face shields
- Respirators
- Hearing protection
- D3 safety glasses

# **SAFETY SHOWERS**

Safety showers and eye wash stations are located throughout the Technology Center. In the event you are exposed to a hazardous chemical proceed to the nearest station and flush with water for a minimum of 15 minutes, then seek medical care.

# HAZARD RECOGNITION AND AVOIDANCE

- PPE is required in lab and work areas
- Everyone in a vehicle must wear a seatbelt at all times
- Vehicles parked on a grade must have the parking brake set and be chocked
- Mobile equipment must be chocked when parked
- Stay clear of working mobile equipment and highway trucks as the operator may not see you
- No drugs or alcohol or explosives on premises including personal vehicles
- Situational awareness must be maintained while outdoors for variable conditions etc. traffic, wildlife, lightning
- Be alert for slip, trip, and fall hazards
- Do not walk under suspended loads
- Use proper eye protection in areas where cutting and welding work is being done
- Visitors must have an escort when entering a location outside of their intended work area
- No smoking in buildings and observe all no smoking areas
- Emergency showers and eye wash stations are located throughout site
- Xray is in use in several areas of the Technology Center; keep out of areas when in use
- Microwaves are in use at our facility. If you have an implanted medical device (i.e., Pacemaker) ask about the specific location of microwave devices
- Robotics are present on our sites. Do not enter robotics enclosures unless training, authorization, and LOTOTO requirements are completed

# WILDLIFE

The Technology Center is home to a variety of desert wildlife. Be cautious while on property and immediately report any dangerous wildlife encountered. Do not touch or feed wildlife.
